INTRODUCTION

- Universal Health Care is a shared vision that aims to provide essential healthcare services to all individuals, regardless of their financial status or geographic location.
- Comprehensive approach involving not only access to care but also quality care.
- **Skilled healthcare workforce** is fundamental to delivering high-quality healthcare services.
- Continuous Professional Development (CPD) ensures that healthcare practitioners continuously update their knowledge, skills, and attitudes hence remaining competent and up-to-date with the latest medical advancements.



WHY CPD

- Helps reduce the risk of medical errors and adverse events and encourages practitioners to stay informed about new treatment protocols, safety measures, and best practices.
- BMJ Quality & Safety Journal 2017 study: The rate of preventable adverse events in hospitals in sub-Saharan Africa was 11.4%, and that of medication errors was 14.3%
- Link between CPD and Quality: Up-to-date healthcare professionals are more likely to make informed decisions, leading to improved patient outcomes.





The Challenge...



• Healthcare Professionals need constant access to up-to-date information that is relevant to their practice. This directly influences patient outcomes.

• Traditionally, Continuous Medical Education (CME) events have been hosted in large cities. This has disadvantaged healthcare professionals in far-flung areas as well as those who are unable to physically attend CME events






CME Needs Assessment Survey

- Shared via email to 18K+ HCPs
- 790 respondents;
 - 28% Doctors& Dentists, 44% Pharmacists, 14% Nurses, 14% other allied HCPs
- **Practice setting:** 65% Hospitals, 26% Private Practice, and the rest from Industry, Government Agencies, Research and Academia
- Country of Practice: 97% Kenya, 3% ten African Countries(Nigeria, Cameroon, Tanzania, South Africa, Rwanda, Senegal, Liberia, Ghana, Egypt, Uganda)










WHAT INFLUENCES CHOICE OF CMEs

The rationale for CME selection










Does your facility have any CPD program















Mode of training you prefer

A BRIEF HISTORY OF THE COMPANY

The Early Days

Daktari Online was founded in 2011 as a pilot project to establish the concept of continuous online learning for healthcare professionals (HCPs), which later became a full-fledged company in 2015 under the name Daktari Media Africa LLC.

Expansion and growth

In 2017, Daktari Online registered 185 healthcare professionals and was accredited as the first online CPD provider by the KMPDC. In 2018, we integrated with the KMPDC CPD Management portal (iCPD) to comply with mandatory CPD regulations, cementing their position as a top provider of continuous learning for healthcare professionals in Kenya.

Where We Stand Today

Our signed-up users has grown exponentially, with over 20,000 HCPs now using Daktari Online as their go-to CPD provider for professional appraisal and re-licensure. We are now accredited by the Nursing Council of Kenya, Pharmacy and Poisons Board, Clinical Officers Council, and Uganda Medical Council, and we have built a database of 70,000 HCPs across Africa.





We record medical podcasts in audio format provides accessible and informative insights from leading medical experts through interactive discussions




